**Treasurer's Report:** Sarah Twedt, secretary/treasurer, submitted financial reports from 2014-2016. Jeanne Hryniewicki and Heidi Hong signed off on report dated July 1, 2015 – June 30, 2016. Financial report is attached. (Balance in Wells Fargo Savings and Checking accounts as of June 30, 2016: **\$3,445.37**)

**Endowment Report:** Carolyn Nelson reported \$7,754 in the endowment account, and \$5,154 in spendable account. Total: \$12,908.

JCSP Dues/Contributions: Discussion regarding invoices to each state from JCSP. JCSP will begin to send an invoice to each state for annual dues/donation of \$100.

IRS 501(c)3 complete for JC.

Junior Composer Summer Program – JCSP: Lucinda Lear reported the following: "In October 2015, the JCSP by-laws were approved and adopted. In November 2015, JCSP received an EIN number. These items

were then sent with other necessary papers to Duane Langley for application to receive tax-exempt status under the NFMC IRS umbrella. Notification was received in early July that JCSP now has it's own IRS/NFMC group exemption number separate from NCR which will be used to apply for grants. Once the 2016 camp is completed Pat and Catherine will make the necessary transitions with the bank accounts and register with the Minnesota Secretary of State which should provide more grant opportunities within the state."

**Budget committee**: Jeanne Hyrniewicki presented a budget proposal for year 2016-2017.

**Motion:** Jeanne Hyrniewicki moved that state dues to NCR increase to \$300 annually, with \$100 from each state be donated to JCSP. **Motion passed.**
